Women Reserved Seat Nomination Form

Central Executive Committee Elections 2026

Purpose of this form: This form is for women representatives contesting the election for the two seats of the P@SHA Central Executive Committee reserved for women entrepreneurs under Article 10(e) of the Articles of Association (Rule 21(6) of the Trade Organizations Rules 2013), for which the electoral college is the newly elected CEC. The reserved-seat election will be held on Friday, September 18, 2026. It records the candidate's consent, a proposal by one duly registered voter, and a seconding by another. The candidate, proposer, and seconder must each appear on the Final Voter List 2026 as the authorized representative of their member company.

Important note: The Women Reserved Seats are separate from and independent of the open CEC seats. A woman representative may also contest an open CEC seat; to do so she must submit a separate CEC Nomination Form for that category. Nominations for both categories open together on August 24, 2026 and close on August 28, 2026.
