# Achievements

### INDUSTRY

#### Historic package approved from Federal Ministry of Finance

P@SHA took the following initiatives with the support of Ministry of Commerce and Ministry of IT with the facilitation provided by PM IT Task Force. The aim was to resolve IT industry issues by bringing all major stakeholders on-board.

- 5% Cash Reward for IT Exports performance
- PKR 3 Billion allocation for Export Marketing to PSEB
  - 1% of IT & ITES annual exports would be allocated to PSEB each year to carry out HR Skills Development, capacity enhancement of IT companies, branding/marketing & business development, & establishment of software technology parks across Pakistan.
- Sommittee formed with P@SHA, Ministry of IT and Finance to resolve tax issues with FBR
- Long standing demand of the IT Industry is addressed: as per the directions of the Finance Minister, FBR would revise & expand the tax definition of IT/ITES Industry in consultation with the members of the above-mentioned committee formed to ensure coverage of all subsectors.
  - P@SHA has already submitted a revised definition of IT and ITES industry to FBR
- Special Foreign Currency Accounts": Agreement to take steps for facilitating opening foreign currency accounts under the FCA regime for IT & ITeS industry, startups & freelancers.

#### Significant achievements on P@SHA Provincial Policy Engagement Activities

Call Centers in Sindh get the tax exemption on the exports. Previously, call centers were charged 3% sales tax on the exports in Sindh and similarly the rate varies in other provinces.



#### Significant achievements from P@SHA e-Commerce Committee

- Enabled Pakistani Sellers' access to Amazon.
- Worked with State Bank of Pakistan to launch the SAAF Scheme to enable SMEs to get finance from banks without needing collateral.
- POS notification re-issued to allow existing companies (and P@SHA members) to continue operating.
- P@SHA membership necessary for obtaining POS license from FBR based on strong advocacy by Chairman P@SHA, Barkan Saeed.
- Positive advancements on reducing the requirement of paid-up capital for the POS license.

### SECRETARIAT

- The P@SHA secretariat was strengthened by the Human Resource committee
- P@SHA Secretariat has expanded to a team of 8 members by hiring 5 new resources. This is a milestone in the growth of P@SHA and an achievement for the P@SHA CEC and HR Committee.
- Hiring of new resources in Lahore and apart from two resources in Karachi for industry engagement is in-progress. Budget has been allocated for all planned hiring.

### Policy Advocacy & Members' Support

CEC and Chairman P@SHA along with all office bearers played a pivotal role in advocating and providing support to members in the resolution of the IT Industry collective as well individual issues. As a result, they have conducted various meetings, discussions and have taken numerous initiatives in ensuring members achieve the desired progress and success in their businesses.

### **MINISTRY OF FINANCE (MOF)**

#### **Budget Proposal**

- Federal Budget proposals submitted.
- Case on budget announced submitted to Prime Minister Taskforce on IT and Telecommunications.
- Comparative analysis was done for P@SHA Budget Proposal vs. Economic Advisory Committee (EAC).
- Strong Budget Campaign run around lack of benefits provided to IT industry in Pakistan.
- <u>Appeal to Prime Minister Advertisement published in Newspapers.</u>
- Appeal to Prime Minister Video created for the social media.
  - Budget recommendations compiled for Budget Anomaly Committees.

### **FEDERAL BOARD REVENUE (FBR)**

#### **Tax exemption**

- Chairman P@SHA, Federal Minister for IT & Telecom, Secretary IT and MD PSEB call upon the Chairman FBR.
- P@SHA did a <u>press conference</u> to create awareness on adverse effects of the tax credit system.
- Chairman made appearances on TV <u>Kamran Khan Show</u> & <u>92 News</u> and made a strong case on major issues facing our industry.
  - To escalate the tax exemption issue P@SHA wrote a letter to the Prime Minister.
  - Published a <u>Tax Credit Impact Report</u>, which was highly appreciated by stakeholders.



- Conducted a <u>webinar</u> on the "Impact of Tax Credit System" as part of the "<u>Candid with</u> <u>P@SHA</u>" series to help members understand the implications of the tax credit regime and its summary was prepared.
- A survey done among members, and a documented case submitted to FBR with challenges and solutions

#### POS integrated retailers with FBR System

A meeting was planned with FBR, which resulted in a revised notification.

- Detailed feedback was compiled with the help of the industry and was submitted to FBR to which FBR has responded positively to the majority of the recommendations.
- Implementation of rules stopped after P@SHA's meeting with FBR, allowing existing companies to continue operating.
  - P@SHA Membership made mandatory for the POS license by FBR
- Two documents on the compliance requirements and e-Commerce definition are being compiled.

### **HIGHER EDUCATION COMMISSION (HEC)**

#### Human Resource Skill Development

Four concept notes were shared with HEC/MOIT on improving the graduate quality:

Sending IT Professionals to Universities for teaching industry courses on weekends/evenings with healthy remuneration.

Bootcamps by IT companies depending on their size and capacity to train graduates.



A concept note of a 2-year Associate Program was shared with HEC.

Mr. Badar Khushnood also led the conversations to ensure Pakistan's addition to Amazon's authorized sellers' list.

### CHAINSTORE ASSOCIATION OF PAKISTAN (CAP)

An MoU was signed between P@SHA and CAP to help retail businesses and SMEs to explore 'indigenously developed technologies' for their retail and e-commerce operations. This MoU was facilitated by the P@SHA E-Commerce Committee.

### **TRADE DEVELOPMENT AUTHORITY OF PAKISTAN (TDAP)**

#### **Operations of IT/ITES companies to continue during lockdown**

Chairman P@SHA, Barkan Saeed and Director Marketing & Comms, Talha Bin Afzal closely worked with TDAP to allow IT companies/call centers to operate 3 days during official Eid holidays.





### **PAKISTAN TELECOMMUNICATION AUTHORITY (PTA)**

#### **IP** Whitelisting Issues

CEC Member, Mujeeb Zahur assisted in escalating IP Whitelisting issues with PTA.



The IP Whitelisting issue of CureMD was resolved with the help of letters sent by P@SHA. The discussions for the simplification of the process are underway. The current regulation for the IP Whitelisting is available <u>here</u>.

The flow of the new system for IP Whitelisting which is developed by PSEB was reviewed by P@SHA.

### **FEDERAL INVESTIGATION AUTHORITY (FIA)**

#### **FIA Raid Against Companies**



Chairman P@SHA also wrote a letter to the FIA Director General.

On P@SHA's request, MoITT has worked with Interior ministry to get the matter investigated with the Interior Ministry to ensure matter to be investigated and find the real culprits.

### **STATE BANK OF PAKISTAN (SBP)**

CEC Member, Shahzad Shahid led the discussion in resolving these issues with the SBP.



Feedback on the policy of equity holding and investment abroad was shared with State Bank by CEC and some of its general body members.



Payment issues of members i.e. Game District and Finz were escalated & resolved by P@SHA.

Proposal to SBP for increasing the limit of outward forex remittances to 33% of the revenue for P@SHA member companies.

### PAKISTAN SOFTWARE EXPORT BOARD (PSEB)

- Chairman and CEC member, Mujeeb Zahur worked on steering committee for IT certification.
  P@SHA raised the issue of irregularities in the project with the concerned authorities based on which an inquiry was performed and involved employees were laid off.
  Asked PSEB to improve the project and make it beneficial for IT companies.
  The issue of PSEB doing internet business and taking fees from P@SHA members was raised with PSEB and that PSEB should not charge any recurring fee from members.
  Feedback on projects initiated by PSEB was given by CEC.
  P@SHA communicated offer to PSEB to build PSEB Software Parks on PPP model.
  Consulted industry and feedback provided on Industry Whitepapers.
  - The Industry Internship Program for efficient placements was led by Salman Dar.
  - Participation by Barkan, Mujeeb, and Salman in the Evaluation Committee for the hiring of a vendor for the IT Industry Landscape Study of Pakistan.

### **MINISTRY OF IT & TELECOM (MOITT)**

#### Pakistan Digital Policy / Make in Pakistan



- The case against PSEB Registration Fee for P@SHA members sent to MoITT.
- P@SHA is working on 'Make in Pakistan' policy along with MoITT. Proposal for the changes in PPRA rules was presented.

### **P@SHA IMPACT ANALYSIS OF REMOVAL OF TAX EXEMPTION**

P@SHA released an <u>impact analysis of removal of tax exemption</u> to create understanding for the industry as well as raise awareness in the relevant government stakeholders. It also included a comparison of benefits provided to Pakistan vs. other countries which went viral and became the basis of the campaign by P@SHA during the budget cycle and eventually led to the historic package for the IT and ITES industry by the government.

### **P@SHA IT SALARY SURVEY 2021**

P@SHA successfully resumed its much-awaited flagship initiative. The aim of <u>P@SHA IT Salary</u> 2021 is to help the IT and ITES industry in performance evaluation and increments, allow salary benchmarking, analyze, and address reasons behind employee turnover rates. It includes an analysis of salaries, benefits, and increments of employees working in the IT industry of Pakistan. This time P@SHA IT Salary Survey Report 2021 covers **62 roles** and **225 jobs**. We have received overwhelming participation from **175 companies** and **30,000 employees** to make it more comprehensive than ever! It included a section on University Rankings which has gone viral. The report will lead to different planned initiatives (Industry Readiness Framework) and other reports.

### P@SHA D&J Framework for the IT companies of Pakistan

The <u>report</u> provides guidelines that can enable companies to improve and ensure diversity and inclusion at their workplaces. This report has covered in detail; D&I benchmarking toolkit, D&I action plan, P@SHA's D&I certification plan, diversity-based hiring practices & policies, infrastructure support for a diverse workplace, government laws and policies regarding diversity and inclusion, and employee engagement initiatives and policies.

### **EMPOWERING & STRENGTHENING MEMBERS**

P@SHA has recently launched its 'D&I Pilot program' to implement the recommended D&I benchmarking tool and action plan with the six companies. For this purpose, six companies of different backgrounds are selected from each region to ensure fairness and inclusivity. Moreover, it will also test the effectiveness of the framework and benchmarking tool concerning the demographics of different regions.

### **Enablement Programs**

Under the on-going initiatives that were led by the P@SHA Skills Development and Training Committee, a total of 540 participants have availed programs from November 2020 to September 2021. A total of 133 active P@SHA member companies benefited from these programs. Out of which 53 companies were from the Central Region, 35 from North and 45 from South. So far 14 MoUs have been signed by the Skills Development and Training Committee.

### **P@SHA SKILL DEVELOPMENT PROGRAM**

Under the guidance of Chair P@SHA Skill Development & Training Committee, Shamim Rajani along with other committee members, P@SHA Secretariat has launched the following programs recently.

### **CXO MENTORSHIP PROGRAM**

From one CXO to another, this initiative enables the flow of knowledge and experiences of the larger companies with the smaller ones with great potential to grow with respect to lead generation, operational matters, skills development, retention, scaling, organizational policy and others.



Mentees from 11 active P@SHA member companies participated in the P@SHA CXO Mentorship Program. Out of which 03 mentees were from the Central Region, 03 from North and 05 from South.

### **DEPARTMENTAL COACHING PROGRAM**

P@SHA's Departmental Coaching Program has been created to provide coaching to member companies who require guidance and direction on day-to-day departmental issues. The training has received excellent response from our member companies in terms of improving skill set and staying afloat with the latest technology trends.



Participants from 22 active P@SHA member companies completed their one-to-one probono coaching through P@SHA Departmental Coaching Program. Out of which 08 companies were from the Central Region, 06 from North and 08 from South.



### **P@SHA SKILL DEVELOPMENT PROGRAM (PSDP)**

PSDP was launched in March 2021, based on the survey analyzing the top training requirements of the member companies. The identified areas were Agile Methodologies, MEAN & MERN stack, Cloud technologies including Azure, AWS and Google Cloud, Artificial Intelligence, Big Data and Data Sciences, DevOps and Quality Assurance.



For the 1st cohort, 20 companies signed up, out of which 10 of them were onboarded after the initial screening process. For the 2nd cohort, 13 companies showed interest to offer their training services, out of which 4 of them passed the initial screening process. An MoU will be signed with them in early October.

Participants from around 20+ active P@SHA member companies availed the discounted training courses offered by our esteem training partners under the P@SHA Skill Development Program. Out of which 07 companies were from the Central Region, 06 from North and 08 from South.

### **MASTER CLASS**

Started in April, Master Class by P@SHA is a series of interactive free workshops, training and panel discussions revolving around the latest technologies, skill-sets and best practices. All Skill initiatives have been led by the P@SHA Skill Development and Training Committee.



Attendees from around 80 active P@SHA member companies participated in the P@SHA Master Class Program. Of which 34 companies were from the Central Region, 19 from North and 24 from South.



### **P@SHA ACADEMIA-BRIDGE PROGRAM**

Launched Academia-Bridge Program with the first tripartite MOU with Contour Software, one of Pakistan's leading companies, and Sir Syed University of Technology, Karachi. As part of this partnership, a core course (Web Engineering) will be taught by Contour professionals to students from SSUET. The response has been overwhelming. They have already enrolled 250 students in the Web Engineering elective course.

### **DIVERSITY & INCLUSIVITY FRAMEWORK**

P@SHA Diversity & Inclusion Sub Committee is currently working with the Secretariat on a D&I benchmarking tool and framework. This framework and benchmarking tool will be used by companies to ensure D&I policies and practices implementation in the IT industry.

The framework has led to the launch of the D&I Pilot with 6 companies across Pakistan to test and improve the benchmarking toolkit. In addition to this, partnerships with S&P Global and SheReturns have been done to promote diversity initiatives across Pakistan

### **PROWOMEN - DIRECTORY OF FEMALE PROFESSIONALS**

In 2019, P@SHA collaborated with CodeGirls Pakistan to create <u>ProWomen</u>, an accessible platform where female professionals can be contacted as speakers, trainers, consultants, board members and for other relevant jobs and assignments. Today, details about 1,250 women from various fields have been documented in the ProWomen directory in over 32 industries.
