

P@SHA ELECTION SCHEDULE 2022

FOLLOWING SECTIONS 13 TO 19 OF THE TRADE ORGANISATION RULES 2013

Monday, July 18, 2022	Approval of the Election Schedule and appointment of the
Wonday, July 18, 2022	Election Commission by the CEC

Rule 14 sub-rule 2: Within two days of the approval by the CEC the election schedule shall be displayed

Tuesday, July 10, 2022	Announcement of the Election Schedule and the Election
Tuesday, July 19, 2022	Commission

Rule 18 sub-rule 2: Within three days of the announcement of the election schedule, member firms desiring to change their representative shall intimate changes regarding the name of the representative to the Secretary-General along with necessary proof of eligibility

Friday, July 22, 2022 Last date for changing Authorized Representative

Rule 18 sub-rule 3: The Secretary-General of the trade organization shall display, within seven days of the announcement of the election schedule, the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number of their representative.

Monday, July 25, 2022

Provisional Voter list displayed

Rule 18 sub-rule 4: The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary-General within seven days of the issuance of the voters' list.

Monday, August 1, 2022 Last date for filing an objection to Voters List to the Secretary-General

Rule 18 sub-rule 5: The Secretary-General shall, within five days from receipt of objections under sub-rule (4), intimate action on the objections or changes, if any.

Wednesday, August 3, 2022 Last date for Secretary-General to resolve any objections filed.

Rule 18 sub-rule 6: Any person aggrieved by the decision of the Secretary-General may, within three days of receipt of the decision, make a representation to the Election Commission which shall decide the representation within three days.

Saturday, August 6, 2022	Last date for members to report to the Election Commission if their objections are not resolved/ delayed by the Secretary-

Thursday, August 11, 2022 Last date for the Election Commission to resolve the objection

Rule 18 sub-rule 7: Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (6), make an appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final.

Monday, August 15, 2022	Any member not satisfied with the decision of the election commission or if the case has been delayed, members can approach the Regulator

Thursday, August 25, 2022	Last date for the Regulator to settle objections and provide the
Thursday, August 25, 2022	final decision of the eligible voters (within 10 days of appeal)

Rule 18 sub-rule 8: Within two days of the decision of the Regulator the final voters' list shall be displayed.

Friday, August 26, 2022	Final Voter List to be displayed and Nomination for CEC Elections

Rule 18 sub-rule 9: Within four days of display of the final list of voters, any person, who is eligible to contest elections for the vacant post, shall send his nomination, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary-General.

Wednesday, August 31, 2022	Last date for receipt of Nominations for CEC sent to the Secretary-General (proposed and seconded by existing paid P@SHA members) within 4 days of the final voter list being posted

Rule 18 sub-rule 11: The nomination papers shall be scrutinized by the Election Commission and the list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.

Thursday, September 1, 2022

List of approved CEC candidates will be displayed



Rule 18 sub-rule 12: The objections, if any, to the nomination of the candidates may be filed to the Election Commission within twenty-four hours of the issuance of the list of candidates, which shall be decided by the Election Commission within two days.

Friday, Sontomber 2, 2022	Last date to file objections (if any) of the nominated candidates
Friday, September 2, 2022	the Election Commission

Announcement of the AGM 2022 - September 5th, 2022

Manday Sontombor E 2022	Last date for the Election Commission to resolve any objections
Monday, September 5, 2022	filed for the nominated CEC candidates.

Rule 18 sub-rule 13: Within two days of the decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule (12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it within seven days and his decision in this regard shall be final.

Wednesday, September 7, 2022	Last date for candidates to file an appeal to the Regulator if the Election Commission fails to address their grievances (if any)
Wednesday, September 14, 2022	Last date for the Regulator to settle objections and provide the final decision for the nominated CEC candidates (within 7 days of appeal)

Rule 18 sub-rule 14: Within two days of the decision of the Regulator, the Election Commission shall issue the final list of the candidates.

Friday, September 16, 2022 Final list of CEC candidates to be displayed

Rule 18 sub-rule 15: Within five days of the display of the final list of the candidates, the polling for the election of members of the executive committee shall be held.

Thursday, September 22, 2022 Elections for P@SHA Central Executive Committee



Rule 18 sub-rule 16: **Within two days of the polling** as provided in sub-rule (15), any person elected as a member of the executive committee, shall send, to the Election Commission for election as an office bearer, his nomination duly proposed and seconded by an elected executive committee's member and signed by the candidate.

Saturday, September 24, 2022

Last date for elected CEC members to send their Nominations for the Office Bearer position (proposed and seconded by elected CEC members) to the Election Commission

Rule 18 sub-rule 17: The nomination papers shall be scrutinized by the Election Commission and the list of candidates shall be displayed **within twenty-four hours of the last date of receipt of nomination** *papers*.

Monday, September 26, 2022 List of Office Bearer Nominations will be displayed

Rule 18 sub-rule 18: Within two days of the display of the final list of the candidates, the polling for *the election of office bearers shall be held.*

Wednesday, September 28, 2022 Office Bearer Elections

Rule 18 sub-rule 19: The final result of the election of members of the executive committee and officebearers shall be officially announced at an annual general meeting of the trade organization called for this purpose within fifteen days of the date of polling under sub-rule (18) but not later than-

(b) in the case of all other trade organizations, the 30th day of September of the year.

Friday, September 30, 2022

AGM & Announcement of CEC & Office Bearers for the year 2022-2023

AGM has to be announced 21 days in advance

The election results shall be submitted to the regulator within 7 days of the AGM

Election Procedure

The CEC elections will take place on September 22nd for the final nominated candidates.

- The voting will take place from 9 am to 5 pm through a secret ballot, postal ballot or proxy is not allowed.
- All voters are requested to bring their CNICs along on Election Day. Remember, only eligible voters can cast the vote.
